

## LETTER OF ANNOUNCEMENT EAMS officially live & next steps

9th February 2023

Further to the <u>Letter of Announcement</u> shared on 6<sup>th</sup> February, EMVO is pleased to confirm that the **European Alert Management System (EAMS) Hub is officially live today, Thursday 9<sup>th</sup> February 2023.** Therefore, all interested OBPs and NMVOs in using the system can start connecting from now onwards. Please note that the use of the system does not include any additional fees.

To answer any questions you may have regarding the EAMS on-boarding, **the EMVO Helpdesk will exceptionally remain available during the upcoming weekend**. You can contact us at +32 (0)2 657 00 08 on Saturday 11<sup>th</sup> February and Sunday 12<sup>th</sup> February from 09:00 to 17:00 CET.

The EAMS aims to assist you in investigating alerts **quickly**, **cost-effectively**, **and efficiently**. Currently, the following functionalities are available:

- Create and manage users and groups
- See the list and details of alerts
- Change status messages and files for one or more alerts
- Export alerts and import actions for mass updates

The reports provide an overview of the main findings and implications and describe recommended actions for OBPs and MAHs.

EMVO is also excited to confirm that **the Cyprus NMVO (KOEF)** is **the first market to connect to the EAMS** in productive use. We hope this further encourages the other markets to follow this example and join the project. EMVO will continue to update the EMVS Community on the status of the connected markets.
